Application for Retired Person's Visa to SA

The form DHA-1738 **must be completed only when you are at the Embassy** - in **BLACK INK** and submitted personally to the Embassy with the following:

1. One (1) recent passport photograph in colour.
2. Proof of funds – The last three months of your bank statement and/or proof of Retirement pensions from the National Insurance Scheme
3. Proof of Accommodation in South Africa
4. Proof of medical cover / Medical insurance
5. Flight details.
6. Medical certificate in respect of the applicant and all members accompanying the applicant.
7. Radiological report
8. Police clearance certificates in respect of all applicants 18 years and older, in respect of all countries where person(s) resided one year or longer
9. For a period of 365 days an open/ return ticket is required.
10. Marriage certificate where applicable.
11. The passport should be valid for not less than 30 days after the expiry of the intended visit. At least two unused pages should be available.
12. Receipt of proof of payment of NOK1087 to be transferred to the Embassy's AC 1503 15 38189
13. Applicants must please indicate whether the passport will be collected from the Embassy. If the passport is to be returned by mail (registered mail) the applicant is requested to forward a self addressed **stamped registered envelope**. Please forward a separate envelope for each passport. The postage fee per passport is between NOK 185.00 to NOK 200.00 for A5 size envelope and NOK 235.00 for A4 size envelope.

ONLY WHEN the application form and ALL the necessary supporting documents have been received, will the Consular Section proceed with the application. From this date, the processing period will be eight (8) weeks.

Application for Medical Treatment Visa to SA

Please print the form DHA -1738 and to **be completed only when you are at the Embassy** in **BLACK INK** and submitted personally to the Embassy with the following:

14. One (1) recent passport photograph in colour.
15. A letter from his or her registered medical practitioner or medical institution within the Republic confirming :
 1. That space is available at the medical institution
 2. The estimated cost of the treatment
 3. Whether or not the disease or ailment is treatable or curable
 4. The treatment schedule; and
 5. The period of intended treatment in the Republic
16. The particular of persons accompanying the applicant
17. The details of and confirmation by, the person or institution responsible for the medical expenses and hospital fees; Provided that in a case where the applicant's medical scheme or employer is not liable for expenses incurred, proof of financial means to cover the medical costs shall be submitted
18. Proof of funds – The last three months of your bank statement. If financed or sponsored by a company/institution, a confirmation letter should be submitted.
19. Proof of accommodation in SA
20. Travel insurance is compulsory.
21. Flight details.
22. Birth certificate (unabridged) where relevant to prove parenthood.
23. Marriage certificate where applicable.
24. The passport should be valid for not less than 30 days after the expiry of the intended visit. At least two unused pages should be available.
25. Receipt of proof of payment of NOK 455 to be transferred to the Embassy's AC 1503 15 38189 (IBAN NO: NO98 15031538189 DNB BANK).
26. Applicants must please indicate whether the passport will be collected from the Embassy. If the passport is to be returned by mail (registered mail) the applicant is requested to forward a self-addressed **stamped registered envelope**. Please forward a separate envelope for each passport. The postage fee per passport is between NOK 185.00 to NOK 200.00 for A5 size envelope and NOK 235.00 for A4 size envelope.
