Application for Visa to SA – More than 90 days

Please print the form DHA -84 and to be completed with **BLACK INK** and submitted personally to the Embassy with the following:

1. One (1) recent passport photograph in colour.
2. A letter of invitation (from the company/institution in South Africa and from the company/ institution which the applicant represents).
3. The company profile, tax and the company registration (Cipro) from both institutions.
If the purpose of the application is for a vacation, the applicant must submit all possible contact details (e.g. contact details of person(s), telephone numbers/addresses or whereabouts in South Africa) **as well as** a confirmation letter from the company/institution in Norway/Iceland.
4. Proof of funds – The last three months of your bank statement. If financed or sponsored by a company/institution, a confirmation letter should be submitted.
5. Travel insurance is compulsory.
6. Flight details.
7. Birth certificate (unabridged) where relevant to prove parenthood.
8. Marriage certificate where applicable.
9. Medical certificate in respect of the applicant and all members accompanying the applicant.
10. Radiological report (A radiological report should not be required in respect of children under the age of 12 years or pregnant women).
11. Police clearance certificates in respect of all applicants 18 years and older, in respect of all countries where person(s) resided one year or longer, to be submitted within twelve months of the application if not immediately available.
12. The passport should be valid for not less than 30 days after the expiry of the intended visit. At least two unused pages should be available.
13. Receipt of proof of payment of NOK 455 to be transferred to the Embassy's AC 1503 15 38189 (IBAN NO: NO98 15031538189 DNB BANK).
14. Applicants must please indicate whether the passport will be collected from the Embassy. If the passport is to be returned by mail (registered mail) the applicant is requested to forward a self addressed **stamped registered envelope**. Please forward a separate envelope for each passport. The postage fee per passport
