As an academic, Professor Tladi has published over 100 publications and was recently presented with the University of Pretoria's Exceptional Academic







# **Curriculum Vitae**

Dire Tladi is a Professor of International Law at the University of Pretoria, where he holds the National Research Foundation South African Research Chairs Initiative of International Constitutional Law and the Future Africa Chair in Global Equity for Africa. He has published well over 100 academic publications (articles, books and chapters in books). He holds a BLC LLB (cum laude) from the University of Pretoria, LLM from the University of Connecticut and a PhD from Erasmus University Rotterdam. He was member of the United Nations (UN) International Law Commission from 2012 to 2022. As a member of the International Law Commission, he held the following positions:

- Chair (2022)
- First Vice Chair (2021)
- General Rapporteur (2014)
- Chair of the Drafting Committee (2013)
- Special Rapporteur on Peremptory Norms of General International Law (2015 – 2022).

Professor Tladi is also member of the *Institut de Droit International* where he serves as a member of the Programme Committee. He was previously a member of the Commission on Epidemics and International Law and he currently serves on the following commissions:

- The Place of Social Justice in International Law
- Harm Prevention Rules Applicable to the Global Commons
- Distributive Justice and Sustainable Development.

Professor Tladi is a member of the International Law Association and a member of the Executive Council of the Association. He is currently the President of the South African Branch of the International Law Association.

He was recently invited to deliver a lecture at the prestigious Hague Academy of International Law. He has presented lectures at many UN regional courses on International Law, including for Latin America and the Caribbean, Africa and Asia (he has attended 16 regional courses since 2013). He has also been invited to present lectures at the University of Singapore's Centre for International Law e-Academy every year since its inception.

Professor Tladi was lead counsel for South Africa before the International Criminal Court (ICC) Pre-Trial Chamber and counsel for the African Union (AU) before the ICC Appeals Chamber in the case concerning the Hashemite Kingdom of Jordan. Professor Tladi is also co-counsel for the governments of Sierra Leone and Mozambique in the pending International Tribunal for the Law of the Sea advisory opinion proceedings on the climate change-related obligations under the Law of the Sea Convention.

He has also appeared as a legal expert on behalf of the Government of Lesotho in an International Centre for Settlement of Investment Disputes arbitration in *Van Zyl v Lesotho*. Other involvement in the peaceful settlement of disputes include:

 Professor Tladi was also an AU legal expert appointed to assist in the dispute between Ethiopia, Sudan and



Egypt concerning the Grand Ethiopia Renaissance Dam

• Serving on the Southern African Development Community legal team to assist three former heads of state (Mbeki, Chissano and Mogae) in the dispute between Tanzania and Malawi.

Professor Tladi also had a distinguished career as a member of South Africa's Department of International Relations and Cooperation (DIRCO) between 2006 and 2014. In that time, he served as Principal State Law Adviser (2006 to 2009 and 2013 to 2014) and as Legal Adviser to the South African Permanent Mission. After leaving DIRCO, Professor Tladi continued to assist government as adviser to the former Minister of International Relations and Cooperation. Professor Tladi's contribution to international law through his diplomatic service includes the following highlights:

- being instrumental in the process that led to the adoption of the new treaty on biodiversity in areas beyond national jurisdiction, first as a delegate, then as an adviser to African states and other organisations and finally as a facilitator of various informal meetings among governments
- being instrumental in the decision of

the Seabed Authority to request an advisory opinion from the Seabed Disputes Chamber of the International Tribunal for the Law of the Sea on the responsibilities of sponsoring states

 playing a leading role in the decision by the UN Security Council to adopt Resolution 1989, bringing sanctions listing and delisting procedures more in line with human rights standards.
